WHEREAS in terms of Section 14(1) of the NCTE Act, Satyam College of Education, C 56A/14 & 15, Sector - 62, Nolda, U.P. - 201305 has submitted an application (code No. 04877) to the Northern Regional Committee of NCTE for grant of recognition for B.Ed. Course of one year duration with an annual intake of 100 (One hundred Only) students.

- AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- NOW, THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition Satyam College of Education, C 56A/14 & 15, Sector - 62, Noida, U.P. - 201305 for conducting B.Ed. Course of one year duration with an annual intake of 100 (One hundred only) students under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:
  - The institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
  - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc. wherever applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or Issued there under, the Regional Committee may withgraw the recognition under the provisions of Section 17(1) of the OR THISTE ACT.

- 1. Your application for requesting affiliation for the Bachelor of Education course for the academic year 2008-09.
- NCTE letter No. F.NRC/NCTE/F-7/UP-2652/2008/41752-41758 dated 18.3.2008 received from the Regional Director, Northern Regional Committee, NCTE, Jaipur Region, giving recognition of Secondary Level Teacher Training Institution, with intake of 100 students for Bachelor of Education course for the academic year 2008-09.
- 3. As per Supreme Court Order dated 31.3.2006 in CA No. 1859/2006 in Special Leave Petition (SLP) Civil 13 No. 20918/2005, the Vice-Chancellor vice order No. Affi-Gen-1/V.C. Order/2008-09/412 dated July 11, 2008 has granted the First Time Affiliation to the Bachelor of Education course, conducted by the Satyam Charitable Trust's Satyam College of Education, C-56 A/14-15, Sector 62, Noida 201305 (U.P.), for the academic year 2008-09.

The First Time Affiliation is granted subject to the submission of written undertaking by the Trust, agreeing to fulfill all the conditions of affiliation as stipulated under Section 81, 82 and 83 of the Maharashtra Universities Act 1994, within prescribed time limit and that on default, the First Time Affiliation so granted shall be withdrawn / terminated, as per the procedure laid down for the purpose.

It may be noted that, the First Time Affiliation has been granted for one academic year (i.e. June 2008 -May 2009) to teach the following subjects/ methods at the Bachelor of Education course.

### B.Ed. (English medium)

- 1. Hindi Method
- 2. English Method
- Social Science Method

- 5. Commerce Method
- 6. Science Method
- 7. Economics Method

The First Time Affiliation to the Bachelor of Education course for the academic year 2008-09 is granted on the following terms and conditions:

- The joining report of the above faculty, needs to be submitted to the University within one month from the receipt of this letter.
- That the Trust / Sanstha / Mandal / Society shall appoint the following staff, as per the qualifications and procedures prescribed by the University Grants Commission / University.
  - a. Teaching staff including Principal
  - b. Librarian
  - c. Non-teaching staff
  - d. Technical / Laboratory staff, wherever applicable
- That the Trust / Sanstha / Mandal / Society shall meet the financial deficits, if any, by making an outright grant to the college from its own funds.
- That the Trust shall maintain the rosters for reservation of posts of teaching and non-teaching staff, as per the reservation policy of the State Government and maintain service books and the provident fund registers of all employees.
- That the Trust shall provide facilities for library, books and journals, furniture, fixtures and fittings for class room, office laboratories, library and staff room.
- That the Trust shall constitute the Local Managing Committee, as prescribed under Section 85 of the-Maharashtra Universities Act, 1994 (copy enclosed).
- That the Trust shall comply with the conditions laid down by the concerned State Government with regard to admission of students belonging to SC/ST/DT NT/OBC categories.
- That the Trust shall comply with the orders / directives issued by the Chancellor, the Vice-Chancellor and other officers of the University in exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances, Rules and Regulations.
- That the Trust shall send to the University, the progress reports of the compliance of the above conditions from time to time.

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Norms and Procedure) Regulations, 2009, the National Council for Teacher Education (Recognition 01.12.2014.

- AND WHEREAS, the recognition was granted by NRC to Satyam College of Education, C- 56A/14 & 15, Sector 62, Noida, 201305. State- Uttar Pradesh for B.Ed. Course vides order no. F.NRC/NCTE/F-7/UP-2652/2008/41752-41758 dated 18.03.2008 with an annual intake of 100 seats.
- AND WHEREAS, the said institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to
  the institution fulfilling following conditions namely.
  - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforms available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
  - (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Satyam College of Education, C-56A/14 & 15, Sector 62, Noida, 201305, State-Uitar Pradesh for conducting B.Ed. programme of two years duration with an annual Intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

This deposit will have to be renewed with the accrued interest for further 6 years at the end of maturity date i.e. after 6 years and the copy of the receipt of the fixed deposit be produced to this University.
- 11. That the Trust / Sanstha / Mandal / Society shall give an undertaking on stamp paper worth Rs. 100 wherein it will agree to comply with all the conditions for affiliation laid down under Section 81 of the Maharashtra Universities Act, 1994 and also agree to abide by the rules and regulations as may be framed by the University from time to time.

You are requested to note the same and do the needful and send a copy of the undertaking referred at Sr. No. 11 hereinabove urgently.
